



Site Use & Rules

Site and Grounds:

- Keep all areas in a clean and sanitary condition.
- Do not litter; clean up debris.
- Do not pick plants, cut, or damage trees.
- Make campfires only in designated areas *and* only with the permission of Pilgrim Firs.
- Pilgrim Firs staff housing and parking areas are off limits.
- Please report all items in need of repair to Pilgrim Firs staff.

Housing and Housekeeping:

- Pilgrim Firs will provide linens, including: bed sheets, pillow with case, bath towel, wash cloth, comforter, and blankets. Participants are responsible for making and stripping their own bed.
- Participants are responsible for cleanliness of cabins and lodges while in residence.
- Participants are responsible for returning all areas to the condition and setting as found upon arrival and following the check-out guidelines.
- Please do not leave cabin windows and doors open with heat on.
- Please turn out lights in cabins and lodges before leaving.
- All cabins have a small mini refrigerator and coffee station. Lodges have small kitchens for guest use and snack preparation. Please store all foods safely.

Food Service:

- The main kitchen is not available for use or storage by participants. Pilgrim Firs maintains a kitchen staff for the preparation and service of meals.
- Pilgrim Firs' kitchen provides balanced, buffet-style meals and accommodates the following dietary needs: gluten-free, dairy-free, vegetarian, vegan, life-threatening allergies, and any combination of those. We are unable to provide specific options for other dietary choices.
- Pilgrim Firs will set tables with tablecloths, napkins, and salt & pepper. Users are responsible for wiping down tables and sweeping floors after each meal.

Lake Use:

- Pilgrim Firs does not provide lifeguards. You are responsible for providing lifeguards for your event.
- All participants who engage in swimming **or** boating do so at their own risk and must submit a liability waiver.

Pets and Service Animals:

- No pets are allowed at Pilgrim Firs.
- ADA-certified service animals are permitted with prior approval of the Director

Vehicles and Parking:

- Pilgrim Firs maintains a **5MPH** speed limit throughout the site.
- Park only in designated parking spaces.
- Participants with mobility concerns are permitted to park at their housing space. **NEVER BLOCK OR IMPEDE THE ROAD.** They are emergency fire lanes.

Fireworks, Smoking, and Alcohol Use:

- Pilgrim Firs permits beer & wine use in moderation only with prior written consent of the Director. Absolutely no alcohol use by or with minors under the age of twenty-one.
- Smoking and vaping is allowed only at areas specifically designated.
- No smoking or vaping in buildings or in the woods.
- No fireworks of any kind at any time.

Damage, Destruction & Loss:

- Users are responsible for preventing damage or destruction or loss of Pilgrim Firs property, including but not limited to the land, trees and plants, improvements, equipment, furnishings, and appliances. Repair and replacement costs for these damages or losses will be charged to the responsible user.

Injuries to Users:

- User groups are responsible for the safety and conduct of their participants. Users shall ensure that their participants understand and follow Pilgrim Firs rules and responsibilities and the advice or warnings of the staff. Pilgrim Firs will not be held responsible for injuries except for injuries caused by its own negligence. Users will indemnify and hold owner and Pilgrim Firs harmless from all claims and demands arising out of participant injuries except where Pilgrim Firs is found negligent.
